**International Students requesting a Form I-20 from Stevens must submit a completed FVF**

### Instructions

#### Complete Parts I, III and IV of the FVF if:

- A portion of your financial support comes from a sponsor (parents, relatives, friends, etc.)
- You have more than one sponsor or a financial document submitted as proof of funds that is a joint account. A separate page #2 of the FVF must be submitted for each sponsor or account holder named on the financial documents provided.

#### Complete Parts I and IV of the FVF if:

- Your education and living expenses will be covered by personal funds, an education loan, or by a scholarship from either Stevens or your home government. If this applies to you, please complete only Part I and Part IV of the FVF.

#### Submitting your FVF

- Signatures must be in ink or digitally certified. An incomplete FVF will delay the issuance of your Form I-20
