


STEM OPT Extension: Filing I-765 Online Guide

This guide is a useful tool for students applying for the <u>STEM OPT Extension</u> using the online application form with USCIS.

*Please note that this guide is to help students with completing the Online I-765 Form with USCIS and should not be taken as legal advice.

**It is very important that you do not submit your online I-765 Form without uploading your STEM OPT Requested I-20 from ISSS.

**STEM OPT Applications must be submitted to USCIS within 60 days of the I-20 issuance date or

TIP: Check page 2 of your I-20 to confirm the type of Work

Authorization you are applying for.

Enter the degree for which you are requesting the STEM extension (Bachelor, Master, Doctorate, etc.)

Enter your employer's name as listed in E-Verify

Enter your employer's E-Verify Company Identification Number (usually 4-7 digits).

Please note that the E-Verify number is NOT the employer's EIN (9 digits) that was listed on the Form I-983.

OFFICIALLY SUBMITTED and you can no longer make changes or edits to your application.**

Upon submission, the form will prompt you to sign electronically.

Make sure to review all information prior to payment and submission!!!

If your I-20 has been issued more than 60 days prior to your payment/submission date, DO NOT SUBMIT & contact the ISSS Office for a new I-20!

Your STEM OPT Application <u>must</u> be received by USCIS prior to the end date of your Post--Completion OPT!
