\*Students who attend a U.S. school in J-1 status immediately before transferring to Stevens must have their SEVIS record transferred to Stevens from their previous institution before Stevens can issue a DS-2019. To initiate the record transfer, please contact your international student advisor at your previous or current school and request a release of your record. To release your record for transfer purposes, please provide your international student advisor at your previous or current school the following Stevens School code: **P-1-00027**

If you require a change of status to J-1, you may either apply with U.S. Citizenship and Immigration Services (USCIS) or travel outside the U.S and be admitted in J-1 status. If you travel, you must apply for a J-1 visa at a U.S. consulate abroad to be admitted in J-1 status.

**Dependents Accompanying Student:**

Dependents accompanying or following to join an Exchange Visitor (EV) require their own DS-2019s to apply for a visa and to be admitted to the U.S. in J-2 status. For the purpose of visa sponsorship, dependents consist of a spouse and minor children. Dependents in J-2 status will be required to have, and present evidence of health insurance coverage for the duration of the EV's program participation. This is true even if the J-2 will be making short, occasional visits to the U.S. in J-2 status. Dependents who come for short visits only may want to consider a tourist visa (B-2) to visit the U.S.

If requesting a J-2 DS-2019, please provide the information on the following page for each of your dependents and submit copies of the following documents:

- Dependent's passport ID page
- A copy of marriage certificate
- A copy of birth certificates for minor children
- Evidence of funds to support each dependent per year (\$4,500 for spouse, \$3,600 per child), per dependent. Proof of funds may be in the form of a bank statement/ letter, letter verifying government sponsorship, etc. Please refer to our "Guidelines for Submitting Financial Documents" for more information.
